#### 2. Description of an order subject

The subject for the present order is:

2.1. Providing accommodation for 26 persons, from 09 to 15 September in rooms:10 double rooms (with separate beds);6 single rooms.

2.2. Booking a training/meeting room for 26 people in the second and fifth day of the visit (10<sup>th</sup> and 14<sup>th</sup> of September): Monday (9am to 4pm) and Friday (9am to 3pm) (the hour of the dinner will be fixed)

2.3. Providing breakfasts for 26 persons, from 10 to 15 September (with both vegetarian and meat meals). (The breakfast on 15<sup>th</sup> September depends on an hour of departure time from GB. The Ordering Party will provide 7 days before departure the final amount of ordered breakfasts.

2.4. Providing dinners for 26 persons, from 09 to 14 September (with both vegetarian and meat meals). The dinner on 09<sup>th</sup> September depends on an hour of arrival to GB. The Ordering Party will provide 7 days before departure the final amount of ordered dinners.

Rooms must have baths and Internet access (included in the room-price).

The Ordering Party may also request to correct obvious mistakes and calculation errors.

#### 2. <u>Verifying the credibility of offers.</u>

The Ordering Party reserves the right to verify in the course of the evaluation of the offer the credibility of documents, statements, indexes, data and information submitted by Contractors.

# § 1

The present contract was entered as a result of the delivered tender inquiry in the mode of the competitiveness principle.

# § 2

- On the basis of the present contract, the Ordering Party commissions with the Contractor the service of accommodation and meals during 4<sup>th</sup> study visit in GB (Leeds), 09 - 15 September 2012 (hereinafter referred to as "order").
- 2. The subject of the order is to be performed in accordance with the requirements included in the Tender Inquiry (and possible explanations and corrections to the Tender Inquiry) and in accordance with the offer submitted by the Contractor. The copy of the Tender Inquiry and its explanation and changes are included in Enclosure No. 1 to the present contract, whereas a copy of the offer is Enclosure No. 2 to the present contract.
- 3. In case of any discrepancies between the contents of the Tender Inquiry and the Offer of the Contractor, the contents of the Tender Inquiry are decisive.
- 4. The Parties shall allow the possibility of lowering or increasing the number of persons covered with the order subject. The remuneration of the Contractor does not change in such case.
- 5. The Contractor is obliged in the course of performing the present contract to consider suggestions and wishes of the Ordering Party concerning the manner of its performance.
- 6. The Ordering Party may change the dates of performance of the service.
- 7. The Contractor states that the Contractor possesses sufficient personnel and technical resources necessary to realize the subject contract.

#### § 3

1. For the realization of the whole order (with reservations concerning § 2 point 4), the Ordering Party is obliged to pay for the Contractor the total gross amount of: .....), in accordance with

the price-list from an offer.

- 2. The remuneration defined in point 2 shall include all costs incurred by the Contractor due to realization of the order, diligent and in conformity with the contract as well as with binding legal regulations, and in particular the costs of services as enumerated in § 2 of the present contract.
- 3. The Contractor shall not be entitled to claims concerning ordering works for the Contractor.
  - § 4
- 1. Payment for performance of the subject of the present contract shall be provided on the basis of the invoice issued by the Contractor.
- 2. Payment shall be transferred via bank transfer to an account number provided by the Contractor, on the basis of the issued invoice, within 14 days upon the delivery of the properly issued invoice.
- 3. As the day of payment shall be regarded the day of placing the bank transfer order by the Ordering Party.
- 4. The Ordering Party accepts providing the advance payment.

§ 5

- 1. The person indicated in the previous sentence is authorized to undertake current decisions concerning the manner of performance of the contract.

# § 6

- 1. The Ordering Party shall be entitled to terminate the contract in writing without notice in case of:
  - 1) not performing or improper performing of the contractual duties by the Contractor;
  - 2) termination of the contract concerning the co-financing/cooperation, on the basis of which the present contract is financed;
  - 3) not transferring by the Agent Unit/Leader the resources for the realization of the present contract.
- 2. The Ordering Party shall be also entitled to terminate the contract in writing with a one-week notice.

§ 7

- 1. All possible litigations between the Parties resulting from the present contract shall be resolved without undue delay, in the way of mutual negotiations.
- 2. Should such negotiations fail, the disputes shall be settled by the court proper for the seat and jurisdiction of the Ordering Party.
- 3. The gross remuneration as defined in the present contract shall be subject to changes depending on the alterations concerning VAT tax rates.

§ 8

- 1. The contract shall be binding upon a day of its signing by authorized representatives of the Parties.
- 2. The contract was drawn in two identical copies, one for each Party.
